

## Wave Quantum - Terms of use

You are acquiring the right to use Wave Quantum therapeutic technologies.

The object of this document is to provide the necessary and adequate usability, support and support to the indicated, being the final consumer customer, so that they can develop the contemplated activities and usability in its entirety.

Single paragraph:

All customer support will be provided by the reseller directly connected to you. Both the Monitoring in the understanding of the technologies, recording of the vowel frequency, configuration for usability, as well as the forms of payments.

Objective and clarifications: All therapeutic content is made available through a virtual therapeutic office in digital form through a virtual environment.

As a digital content in online form mentioned, it is mandatory that the product will be made available in person, but via the Internet, using technological information and communication tools and a virtual environment so that the user can access and use the therapies autonomously. through login and password.

The access period to the therapies will be 30 days or one month, and can be renewed with a new payment.

### User Customer Obligations

1. Keep your registration data updated.
2. Have equipment and software to monitor and practice virtual therapies that meet the minimum requirements pre-established by the CONTRACTOR, namely: a computer, Not Book, Tablet or smartphone with broadband internet access, with access to one of the following browsers: Google Chrome, Internet Explorer, Mozilla or Firefox.
3. The CONTRACTOR is not responsible for any technical problems of access to the internet, therapies or the Virtual Platform, or for performance problems of the CLIENT / USER's provider as well as internal network configurations that, eventually, need special configuration for access to the CONTRACTOR's environment.
4. It is highly recommended to the CLIENT / USER to participate in online therapeutic lives. They are recorded on a youtube channel. The Seller is responsible for informing the customer access link.
5. The CONTRACTED PARTY reserves the right to make improvements and improvements to the Virtual Therapeutic Office, and may, therefore, change its content and / or technical modality, provided there is prior notice to (the) Client / user.
6. PAYMENT §1 - Payment can be made directly at the virtual office or to the Reseller who is responsible for the activation. The accepted modality within the therapeutic virtual office are cryptocurrencies.
7. The Customer / user declares to be aware that the payment option to the Reseller is of their free choice, and the modality between the parties is agreed: Reseller and customer / user.

8. The payment of the client / user (a) will be considered as effective and will give the official right to access the therapeutic virtual office from the confirmation of a successful transfer to Wave Quantum.
9. It is up to the Reseller to inform the user client that his virtual office is free for activation, recording of vowel frequency, and Easy scanning. There is no possibility of reversing the amount paid.
10. The client acknowledges that, after paying and having access to the Wave Quantum therapeutic virtual office, recording the vowel frequency and facial scanning, he will use the services in digital therapeutic form for 30 days or a month.
11. The non-use by the Client / user of the therapies, non-use of the resources and access to the virtual platform made available to him, does not exempt him from payments, and from his obligations, and any type of return or reimbursement by the CONTRACTED PARTY is not due (Wave Quantum).
12. After 30 days or a month from the payment date, a new invoice will be automatically generated. The client / user will pay if they wish to continue using the Wave Quantum therapeutic virtual office. Failure to pay for 7 (seven) consecutive days generates a block in the use of therapeutic technologies available within the Wave Quantum therapeutic virtual office. Each month of non-use generates a new invoice, which accumulates gradually. In case the customer / user wants to make a new registration, he is completely free to use the same data with the exception of the login. Thus, he is free from the old registration invoices, knowing that he does not generate any type of pending with the company if he does not use the therapeutic virtual office after the monthly fee has expired.
